We have to no avail requested that the Police Chief and the Police Services Board provide certain information as stated below: Please send me a copy of the Warrant/Contract/Sign Manuals/Letters Patent from your Sovereign

City of Brantford Issued a levy against our property, we then requested any documentation that shows we are obligated to the Levy, the levy was placed on our property as a lien. The sheriff attempted an eviction with the help of the Brantford Police. After two failed attempts we continue to ask the Polices Chief and Board to Please send us a copy of the Warrant/Contract/Sign Manuals/Letters Patent from your Sovereign Queen Elizabeth II which apparently enables Her Majesties Office and Agents, the Sheriff and your Brantford Police Officers to evict the Sovereign Kanienke'haka (Mohawk) People from their Homes As we see this as an exclusive treaty issue, outside the scope, influence jurisdiction of the Chief of Police, police officers and Board

Summarize what steps you have taken to try and resolve your complaint including any grievance, appeals and/or requests for reconsideration you have submitted and what response you received

To date we have sent many requests for proof of delegation of authority, an order from the Kanienke'haka people that enables the City of Brantford and the Police Chief and Board to make any determination for Us or our Treaties To-date we have received no response.

We have made many attempts to open a line of communication with the polices services, and board, however due to the nonresponsive nature of these entities, and the upcoming eviction of our members November 30th, ... We have claimed the right to possess the property under acquiescence, and among other things our enjoined treaty entitlements We have also requested that the Police Board provide us with any and all implementation that the Police Services and Board have adopted from the Dudley George Inquiry and Recommendations. To which we have not received and answer, and we believe this may be an attempt to avoid public scrutiny of the fact we are not canadian and that we have requested proof of delegation of authority from Us, which we believe does not exist.
